European Green Deal in context

Ursula von der Leyen elected on 16 July 2019 The European Green Deal was her top priority

"Our goal is to reconcile the economy with our planet, to reconcile the way we produce, the way we consume, with our planet and to make it work for our people [...] This is Europe's man on the moon moment."

Ursula von der Leyen.



EGD Main developments

- 1. <u>Political Declaration + Communication + file by file roll out, month by month</u>
- 2. The EGD was under attack during the Covid-19 crisis but EU kept convictions
- 3. The Russian war in Ukraine instrumentalised to attacked the EGD: EGD recognised as a peace project, strengthened for fossil fuel independence from Russia
- 4. Response to the Brussels Farmers' Strikes: wrong solutions to a real problem: eroding the EGD
- 5. EP election run up much of the EGD is being sacrificed despite best effort by Spanish and Belgian council presidencies, despite progressives in EP, and committed Commission staff

Has the relentless pull of the status quo interests destroyed the "man on the moon moment"? Or can an Agenda of Hope be rekindled?

EGD Mid-term assessment: The good (examples)

- 1. Climate Neutral Europe in Climate Law (March 2020 June 2021)
- 2. ICE sales restriction in Cars legislation for CO2 (July 2021)
- 3. Zero Pollution Action Plan (May 2021)
- 4. The Circular Economy Action Plan (March 2020 and April 2022)
- 5. EU's Biodiversity Strategy for 2030 (May 2020...but see 2024) & Soil Strategy (Nov 2021)

The EGD started well – good on commitments and strategies, some legal innovations, but things have turned.



The mixed / missed opportunities (examples)

1. Fit for 55 package (July and December 2021)

. . . .

- 2. **ZPAP:** Not quite WHO, no Environmental and Outdoor Noise Directives, no light
- 3. Farm to Fork Strategy (May 2020 ...but see 2024)
- 4. Industrial Emissions Directive (IED) proposal (April 2022 weakened 2024)
- 5. The Directive on Corporate Sustainability Due Diligence proposal (February 2022 weakened 2024)

EGD Mid-term assessment: the bad? (examples)

- **1.** Withdrawal of REACH revision (2023)
- 2. Withdrawal of Sustainable Food Systems (SFS) law (2023)
- 3. Withdrawal of Sustainable Use of Pesticides Regulation (2024)
- 4. Opposition to Nature Restoration Law (2024)
- 5. Withdrawal of all biodiversity measures under CAP (2024)
- 6.not over yet.

Nature Alliance (VNA) What do the parties' voting records say about them?



- Methodology
- Based on the individual scoring of the **voting behaviour of every Member of the European Parliament (MEP)** during the 2019-2024 legislative term.
- **3 pillars**: Climate neutral and socially just transition/ Nature positive Europe/ Circular economy and zero pollution.
- Analysis of **30 policy files**: 12 on climate, 8 nature, and 10 on pollution.
- Analysis of MEPs' votes on 124 key amendments.
- Ranking: **Protectors** (scoring between 70-100), **Procrastinators** (scoring between 40-69) and **Prehistoric thinkers** (scoring between 0-39).











EU Parliament Scoreboard

Ranking of EU political groups and national parties based on voting records on climate, nature and pollution legislation.







The Austrian *Greens* and *Social Democrats* score highly, while Renew's *NEOS* party performed slightly better than the Renew group average. All three of these parties were however much stronger in standing up for essential environmental action compared to the two lowestscoring parties: the conservative *ÖVP* and the far-right *FPÖ*.

A commitment to a new social-ecological contract that fosters hope, opens opportunities, creates wellbeing for all, catalyses competitiveness on sustainability across industry and drives the needed transformative system change for a sustainable future

Live Well, within Planetary Boundaries & in Peace and Solidarity

1. Have the European Pact for the Future - A Green and Social Deal for a One-Planet Economy - guide the next 5-year legislative cycle

Flagship Action: Continue to prioritise a transformative green and just transition towards climate neutrality, zero pollution and thriving nature in the next political cycle from the Strategic Agenda onwards.

2. Strengthen an enlarging EU

Flagship action: Roll out the green and just transition in candidate countries with due legal, administrative and financial support, and reform EU governance to ensure decision-making is not undermined by EU growth.

3. Make the safe and sustainable choice the easy choice

Flagship action: Through legislation, incentives and information make the safe and sustainable choices the easy choice for all citizens whether it is mobility, housing, energy, food or other necessary consumables allocating the necessary resources to develop and implement related legislation and revise sustainable public and corporate procurement policy to champion and catalyse the market transformation.

Chart an ecological, social & economic transformation path to 2030, 2040 & 2050

4. Fully address the linked triple planetary climate, biodiversity and pollution crises

Flagship action: Table an Action Plan for 2030 to 2050 to address areas of insufficient progress (in accordance with Art. 5 (2) of the 8EAP regulation), informed by the mid-term review of the 8EAP, EEA indicator report, science and evidence across Europe and the world.

5. Seize the Circular Economy (CE) opportunities and shift to a Wellbeing Economy

Flagship actions: Fast track the CE by resource use & material footprint reduction targets and resource efficiency measures. Embrace an agenda of a Wellbeing Economy & Healthy People

6. Engage all sectors to drive system change for resilience & competitiveness on sustainability

Flagship actions: Ramp up investment in skills, training, job creation and research in key sectors of the green and climate neutral economy, supported by due infrastructure to facilitate competitiveness on sustainability to help vanguard sustainable companies prosper. Design and launch sustainable food systems policy package – a key to constructive system change in a failing policy context for a sector in need. Strengthen chemicals legislation and implementation to support human health and avoid a toxic supply chain and economy.

Promote a Just Transition for an Ecological Transformation

7. Ensure a just transition with a new social contract to leave no one behind

Flagship action: Commit to an EU-wide strategy to address inequalities and end poverty, systematically social proof policies to take account of gender, economic and other inequalities.

8. Strengthen democracy by giving a voice to youth and others too often forgotten

Flagship action: Implement a European Civil Society Strategy and civic dialogue, with a focus on younger generations and marginalised groups, and innovations in participatory democracy.

9. Embrace global responsibilities and drive partnerships to face common challenges

Flagship action: Take responsibility for and scale back Europe's negative international externalities, lead in global diplomacy for multilateral solutions and green-deal type partnerships and systematically push for the respect for the international rule of law in all conflicts to avoid the erosion of a rules-based order essential for peace.

Implement our commitments through investments, governance & rule of law

10. Implement & enforce EU legislation to protect the rule of law and our health

Flagship Action: Set up an Implementation and Enforcement Action plan, with strong focus on upholding the rule of law in Member States, and across the EU.

11. Make EU economies drivers of system change: an investment pact for the future

Flagship action : Commit to an Investment Pact for the Green Deal transition, so all are on board – people and businesses.

12. Strengthen EU governance and trust in the European Project

Flagship action: Appoint a Commission Vice president for the European Green Deal & Social Investments, a VP for Just Transition & Wellbeing.
